CONDITIONS OF ENTRY

1. All Artwork must be for sale.
2. All entries must be original, unaided, not previously awarded a major prize or shown at another Quota Art Show. Copies may breach copyright, please acknowledge a copy in the signature of the painting, e.g. "Inspired by Renault". Competitors shall allow their work to be reproduced by the media without fee for publicity purposes.
3. Once submitted the information on the entry form cannot be altered and only works nominated on the entry form will be accepted. Receipts will only be issued on request.
4. Entry forms and payment confirmation must be received by Tuesday 28th of May 2024, no late entries will be accepted. Please see entry form for payment options.
5. A particular work shall be entered into one category only and entrants can submit a maximum of six (6) entries per artist.
6. Each entry to be clearly marked on the back with the Artists Full Name, Address, Category Entered, Title, Price and, if applicable, any special instructions for collection/return.
7. Artists may submit artist statements per piece of artwork, maximum of 25 words per piece, this is not compulsory and will be displayed in the Art Show Booklet.
8. All works which are to be hung must be fitted with adequate hanging devices for a peg board (sample on the entry form). Note that any works of art that are too big or too heavy will not be hung. Please note due to the volume of entries, artwork must not exceed 1 metre x 1 metre in size. The committee will endeavour to display them depending on space availability, if unsure please contact the Art Show Coordinator on 0414 415 300.
9. Prizes shall be awarded at the judge's discretion. The judge's decision shall be final and binding and so no correspondence/discussion will be entered. Should any dispute arise on a matter for which no specific rule exists, the matter will be determined by the Quota Jimboomba Inc. Art Show Committee.
10. Quota Jimboomba Inc. shall retain twenty-five per cent (25%) commission from the sale price of all works sold. All profits are held in the Community Fund of Quota Jimboomba Inc. and distributed to support the local community.
11. Return freight charges must be pre-paid. The payment confirmation (e.g labels, stamps) must be received before the commencement of the Art Show. The committee agrees to refund the pre-paid return freight and packaging charges for all sold artworks.

12. Art to be delivered and signed into Jimboomba Community Hall, Corner Johanna & Honora Streets Jimboomba, between 9:00am and 1:00pm on Friday 14th June 2024, times cannot be extended. Alternate art drop off times may be available by arrangement, contact the Art Show Coordinator on 0414 415 300 or email quotaartshow@outlook.com.
 13. The organisers accept no liability for loss or damage to entries either during transit or while such entries are in the custody of Quota Jimboomba Inc. However, all due care will be taken of entries submitted. Insurance remains the sole responsibility of the entrant.
 14. Prize winners will be notified after judging on Friday 14th June 2024. Please have your mobiles turned on and try to attend opening night, where we will officially present you with a winner's certificate & voucher where applicable.
 15. Quota Jimboomba Inc. will make all efforts to have payment for sale of artwork paid into artist's bank account within 14 days of completion of art show. Please ensure you supply your Bank BSB and account details.
 16. All unsold works to be collected by the artist. Sold works to be collected by the purchaser at the close of the exhibition, between 1:30pm and 3:30pm on Sunday 16th June 2024. Any Art Show works not collected during these hours will require an appointment to collect. Strictly no artwork will be available for collection earlier; this allows the public to view the artwork on display and increases the chance of sales for the artist.
 17. When items are collected at the conclusion of the Art Show, the collector must be accompanied by a Quota member and artwork must be signed out.
 18. GST Statement - Quota Jimboomba Inc., the organizers of the Quota Art Show, are not a GST registered organization. Accordingly, does not collect GST. Where a work of art is sold from a GST registered artist, the artist will be responsible for remittance of the GST on the sale to the Australian Taxation Office.
 19. Category details below:
 - Category A Traditional Art** - Painting or drawing in any medium of a recognisable subject eg Landscape or portrait.
 - Category B Modern Art** - Painting or drawing in any medium in abstract or contemporary style.
 - Category C Sculpture** - Any Medium eg: Wood, Plastic, Metal, Paper, Fabric, Wool, Pottery, Ceramic, Mosaic.
 - Category D Primary Students** – Primary school aged students only, up to 12 years old. Painting or Drawing in any medium, in any style.
 - Category D Secondary Students** – Secondary school aged students only, from 13 to 17 years old. Painting or Drawing in any medium, in any style.
- Please note that Primary and Secondary school aged students can enter their artwork in any category that they see fit, however these categories are specifically for Primary and Secondary school aged students only.
- Category E All Disabilities** – Painting or Drawing in any medium, in any style for people with disabilities.
 - Category F Photography** – Any subject (please make sure all artwork is ready to be hung).
 - People's Choice Award** – One person will be voted the People's Choice Award on the Opening Night, by the attendees.
